2.1. Classification of the substance or mixture

4.1. Description of first aid measures

5.1. Extinguishing media

dioxide / carbon monoxide. Nitrogen oxides (NO_x). Sulphur oxides (SO_x). Hydrogen fluoride (HF).

5.3. Advice for fire-fighters

Advice for fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

Section 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

Personal precautions: Refer to section 8 of SDS for personal protection details. If outside do not approach from downwind. If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.

Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.

Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method. Do not use equipment in clean-up procedure which may produce sparks.

7.1. Precautions for safe handling

Handling requirements: Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of mists in the air. Smoking is forbidden. Use non-sparking tools. Only use in fume hood. DO NOT distill at atmospheric pressure. Do not distill to dryness. May form explosive peroxides.

Storage conditions: Store in a cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area. Ensure lighting and electrical equipment are not a source of ignition. Recommended storage temp 2-8 °C. Avoid temperatures above 50 °C. Dry residue is explosive. Moisture sensitive. Product reacts with water. Take precautions to avoid contact with atmospheric moisture. Store under Argon.

Suitable packaging: Must only be kept in original packaging. Do not use glass.
